"Identification of local Organizations responsible for Assisted Voluntary Return and Reintegration (AVRR) and monitoring activity of Individual Reintegration Plans (PIR) of migrants who wish to return to their country of origin"

The Information and Education Centre for Development Onlus, CIES ONLUS, project leader of "ERMES 3" project, co-financed by Asylum Migration and Integration Fund 2014-2020, intends to select implementing organizations and/or local operators based in the country of origin, that will undertake the management and monitoring activities of Individual Reintegration Plans (PIR) of migrants who decide to leave Italy and voluntarily return to their country of origin.

Eligible regions and recruitment process requirements

#### **Activities:**

- Feasibility verification of the Individual Reintegration Plan before departure, according to the economic opportunities in the Country of origin and information provision about family's contact persons.
- Identification of socio-economic reintegration opportunities according to the Reintegration Plan developed in Italy;
- Provision of the reintegration subsidy for goods and services, that is functional to the implementation of the Reintegration Plan;
- Orientation and accompaniment, if necessary, to other local service providers.
- Support for PIR implementation and monitoring on site (at least three visits) and production of the reporting documentation (visits checklist and return migrants telephone contacts list, reports of individual visits, final monitoring report, receipt of goods and services);
- Preparation final monitoring and evaluation report about the effectiveness of the implemented interventions;
- Production, management and submission of financial documentation and report (receipts and invoices to evidence all expenditure of the subsidy in goods and services provided).

**Eligible Regions:** the activities listed above must be carried out in countries of origin and primarily in Pakistan.

**Duration:** all the activities for the realization and monitoring of the Individual Reintegration Plan will last six months for each return migrant. The aforementioned activities shall be implemented by December 31<sup>st</sup> 2021 at the latest.

The signing of contracts/agreement between CIES onlus and selected local organization and/or operators will kick off the start of activities.

All required information must be provided, responding clearly and concisely to all the points set out. Any application which does not fully and comprehensively address this request for Expression of Interest may be rejected.

The Application document should be comprised of the following:

- Name of the Country of intervention or adjoining regions where the Organization and/or local operator intends to operate. Candidatures will be selected according to their application in order of arrival, after the evaluation of their CVs.
- Expression of Interest form;
- Curriculum vitae;

The selected Organizations and/or local operator will sign a contract/agreement containing all the terms of reference of the service.
